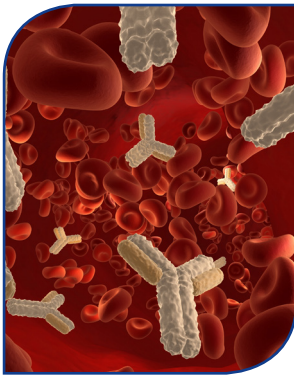


## Microbiology

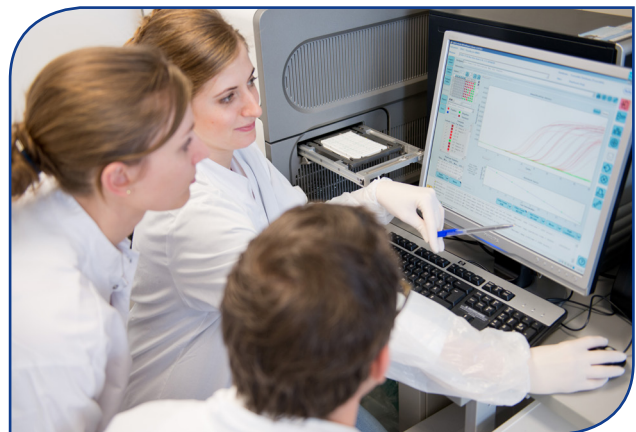


Close customer communication is guaranteed by dedicated expert scientists who are available for consultancy in advance and by direct contact to the study directors during the studies.
